**OBJECT** : According to its regulations and the decisions of the CDI, FISav can write specific regulations for every international competition. This specific regulation is designed to give to FISav members all the practical details needed to enable them to participate. It also gives essential information to those delegated by FISav to organize this important international competition of Savate, in Varaždinske Toplice, Croatia.

## 1 : Conditions of participation in the World Youth Championships

### 1.1 : Federations and National Organisations that can participate:

Only the federations and national organisations **properly affiliated to FISav in the year of the championship (2017)**, having paid their affiliation fees and having no debts to FISav, have the right to enter athletes for the World Youth Championships 2017.

#### **Documents which must be presented at the weigh-in :**

At the weigh-in : The national passport validating the nationality, or other official identity documents proving nationality, the license and the rank card or the athletic passport.  
A medical certificate authorizing the practice of the savate in competition.  
A letter of authorization by the parents.

### 1.2 : Registration Fees

20 euros per athlete

20 euros per out-of-quota coach (see article 3.1.2),

to be paid to FISav by the 11th June 2017 (deadline for nominative inscriptions of the athletes)

### 1.3 : Registration Process :

The inscription of the athletes, coaches and officials (judges and referees) to the World Youth Championship will be made in two phases, **directly to the secretariat of the Fédération Internationale de Savate** : [fisavate@gmail.com](mailto:fisavate@gmail.com)

#### 1.3.1. QUANTITATIVE INSCRIPTION, **DEADLINE SUNDAY 7<sup>TH</sup> MAY 2017.**

1.3.1.1 Inscription using the attached Entry Form

For the ATHLETES, by WEIGHT CATEGORIES, and for the OFFICIALS and COACHES.

Each participating country must complete the entry forms to indicate to FISav the categories in which they will enter athletes, **without giving names**, as well as giving **the names** of the officials and coaches who will accompany them.

**ATTENTION** : In these regulations, the word « **official (s)** » means **only** the people who will take the **roles of judge or referee** in this competition.

The Quantitative Entry forms must be returned to FISav **BEFORE SUNDAY 7<sup>TH</sup> MAY 2017**. **After** this date, a country **cannot** enter athletes for the World Youth Championship 2017. This allows FISav to give advance notice to the organiser, after 7<sup>th</sup> May 2017, of the total number of athletes, officials and coaches who will participate in the World Youth Championship.

### **1.3.2. NOMINATIVE Inscription**

**DEADLINE : MIDNIGHT, SUNDAY 11<sup>TH</sup> JUNE 2017**  
**(DIRECTLY TO THE FEDERATION INTERNATIONALE DE SAVATE)**

#### **THE ATHLÈTES**

- Each country must send the full names of its athletes, on the attached entry form, by Sunday 11<sup>th</sup> June 2017 (inscription deadline at midnight). Without this nominative inscription of the athletes, the country is no longer eligible to participate in the World Youth Championships 2017.

#### **CHANGES OF COACH OR OFFICIAL**

- All changes of coach or official (judge/referee) before the competition must be notified to FISav.
- Attention : In these rules, the word 'official' refers to the persons who will take the role of judge or referee during the competition.

**In registering an athlete for this competition, the national organisation of Savate, member of FISav, takes total responsibility for verifying that the athlete meets all the conditions : medical, age, weight, sex and nationality required by the general regulations of FISav and these special competition regulations.**

*Attention : if the accompanying persons are not officials or coaches, they are not considered part of the official delegation, and the organiser will not be responsible (practically or financially) for his/her accommodation or food.*

*Also, if the Head of Delegation is not a judge, referee or coach, (s)he is not considered part of the Official Delegation and thus the organiser will not be responsible (practically or financially) for his/her accommodation or food.*

### 1.2.3. Visas :

**ATTENTION :** The dates given here do not take into account time delays for gaining visas, which vary from country to country.

**If the wait for a visa is long** in particular countries, this must be taken into account, and the names of participants sent to FISav **early enough**.

## 1.4 : Age Categories :

The World Youth Championships in Savate Assaut are open to athletes (boys and girls) aged at least 15 years and less than 18 years on the day of the weigh-in, the official start of the competition. **It is not possible to have an age derogation for this championship.**

## 1.5 : Engagement :

1.5.1 Registration fee per athlete and out-of-quota coach (by decisions of the CDI on 30 July 2015 and 27 June 2016):

**20 euros**, payable to the FISav before 11<sup>th</sup> June 2017 (date of nominative registration of athletes)

1.5.2 Each country can register **one athlete only** for each weight category.

1.5.3 All athletes must be registered by their national organisation, affiliated to FISav. By this registration, each organisation attests that it has verified, and takes responsibility, for the age, **medical aptitude** as well as the sporting and technical level of the athletes for this form of competition in assaut.

1.5.4 The criteria for national selection are left to the discretion of the participating nations.

1.5.5 The athletes must be insured by their national organisation against all possible risks that could occur as a result of taking part in this competition.

1.5.6 Each country must designate at the time of inscription, **from the coaches or officials (judges and referees)**, a Head of Delegation who will be the spokesperson with FISav and the organiser for his/her country. The Head of Delegation has all powers of decision regarding the athletes and officials of his/her delegation.

1.5.7 A replacement, of the same weight category and age can be designated at the **time of inscription**; the replacement could take part in the competition according to the following principles :

1.5.7.1 **At the time of the Weigh-in for the Championship**, if the officially designated athlete for the country is **absent**. The replacement can be presented to the Délégué Officiel by the Head of Delegation. Once the weigh-in has been made, the replacement becomes the official representative of the national organisation in that weight category. The absent athlete is thus definitively eliminated from this competition.

**1.5.8 Licence Nationality**

Reminder: Volume II - Rules of Procedure of FISav adopted by the general assembly of October 02, 2005 in Paris (France), modified by the general assembly of the FISav of Thursday 30 October 2014 in Rome (Italy)

- Article 11 - § 2: International Competitors: License and Nationality

**General principles:**

- In the course of a sports year, an international competitor must, in principle, only be licensed to the national organization of Savate, affiliated to FISav, of the country of which he is a national.
- In the course of a single sports year, the fact that a competitor is simultaneously licensed in different national bodies affiliated to FISav is not allowed without specific written agreement between the national groupings concerned which would issue these licenses, and prior agreement of the FISav.
- The competitor must present an identity document (passport, identity card ...) attesting to the nationality represented during any participation in the official competitions of the FISav.

- Article 11 - & 2 A: Before 18 years:

**In the case that a competitor has only one nationality,**

- The competitor participating in an official FISav competition may only represent the country of which he / she is a national. Provided that he is at the same time a member of the national body (affiliated to FISav) of which he is a national.

**In the event that a competitor has more than one nationality,**

- The competitor may represent only one country in an official FISav competition. The competitor represents the country of which he is a national and in which he is licensed without being able to represent another nationality until reaching 18 years.

However, as an exception to the preceding provisions, an athlete may participate in an official FISav competition by being presented by a member country affiliated to FISav of which he / she is not a national, provided that the following two cumulative conditions are met:

- a): The athlete (under 18 years of age) must be permanently resident in the country of the affiliated member who has registered them for at least the 3 calendar years preceding the date of the competition. Such permanent residence must be attested by an official document issued by an authorized public authority.

b): There is no official structure affiliated to FISav in the country of which he is a national, or that country of which he is a national, explicitly accepts, and in writing, that he may represent the other country where he resides permanently and where he is actually licenced in Savate, if that country of residence accepts it.

- Article 11 - & 2 B: After 18 years:

**General principle (reminder),**

The competitor cannot represent a country of which he is not a national.

**In the event that a competitor has only one nationality,**

The competitor participating in an official FISav competition may only represent the country of which he / she is a national. He/she is registered by the national organization, affiliated to the FISav, of which he/she has the nationality.

**In the event that a competitor has more than one nationality,**

After 18 years of age, the athlete, at the time of his first registration in an official international competition of the FISav, chooses a nationality of which he holds the passport, without being able to represent another nationality during his whole sports career in Savate.

**Possibility of change of national representation,**

However, as an exception to the previous provision, whilst having more than one nationality, and having already competed in an official international competition of the FISav for a nationality, the athlete may represent another nationality of which he has the passport:

- The nationality he wishes to represent is the nationality of his country of birth, where there never existed an official structure affiliated to FISav. The use of this right by the athlete is irreversible.
- The territory in which he lives and practices Savate (is licenced) changes his nationality due to a constitutional modification (separation, annexation of the territory) recognized by the United Nations.

## 2 : Technical Regulations

### 2.1: Form of competition :

- Minimum Grade: The recommended minimum grade for this competition is "Red Glove".
- All bouts (eliminations & finals) will take place in a regulation ring, with ropes or on regulation mats.

- For the whole competition, the bouts will be in assaut **with protection** (head guard, groin guard (boys & girls), chest protection for girls, mouth guards and shin guards).

- The bouts will be **3 rounds of 1 minute and 30 seconds for all athletes.**

**If only one athlete has entered a category, no final will be held and no title will be awarded in this category.**

## 2.2 : Weight Categories (and glove weights):

The weight categories for athletes and the gloves weights are shown below:

## 2.3 : Protection – equipment (the athletes must have their own equipment, which must conform to the requirements of the FISav texts) :

### Obligatory:

- 1 : Gloves (with laces or velcro)
- 2 : Savate Integrale
- 3 : Savate shoes
- 4 : Mouth guard
- 5 : Shin guards
- 6 : Regulation head guard
- 7 : Groin guard (obligatory for all athletes : male and female)
8. Chest guard obligatory for female athletes

**Protection advised:** hand wraps

The Savate uniform is obligatory : integrale : in one or two pieces covering the body and legs.

Gloves: must be in good condition, in leather or a similar material, with or without laces. The closures of the gloves (laces or velcro) must be sealed with adhesive tape for the whole duration of each bout.

The equipment must be in good condition and conform to the regulations of FISav. Each athletes equipment will be inspected. The Délégué Officiel will refuse all equipment which does not meet the criteria. The uniforms of the athletes must not bear any writings or images which could detract from or cause harm to the Fédération Internationale de Savate.

## 2.4 : Weigh-In

- The weigh-in is obligatory for all participating athletes before the competition. The weights of the athletes must correspond to the category of inscription. **As this is a competition for adolescents, a tolerance of plus or minus 500 g will be accepted.**
- Documents to provide:
  - At the weigh-in: the national passport, or other identity documents, proving the nationality. The licence and grade card or the sports passport.
  - A medical certificate authorizing the practice of the Savate in competition.
  - A letter of authorization by the parents.
- Each athlete has the right to 3 weigh-in attempts to meet his/her weight category within the time assigned for the weigh-in (FISav regulations).
- The weigh-in must take place in two separate places, one reserved for the males and one reserved for the females. This obliges the organiser to provide two sets of scales.
- The Délégué Officiel Général ensures that the weigh-in for the females is undertaken by one or more of the female officials.

## 2.5 : Medical Control :

2.5.1 Before inscription for all competitions in combat, medical examinations are obligatory for all athletes to ensure their aptitude. The examinations are those given in the Medical Regulations of FISav. **These examinations must take place in the country of the athlete, before inscription to the competition, at the charge of the national organisation.**

## 2.5.2 THE NATIONAL ORGANISATION MAKING THE INSCRIPTION ATTESTS :

2.5.2.1 that is has verified and takes responsibility for the **medical aptitude** of each athlete registered for this competition, and that each athlete have **successfully passed the examinations** required in the FISav regulations.

2.5.2.2 that each athlete is insured for all types of injuries and medical problems that could be caused by taking part in this competition. The national federation or organisation assumes all responsibility by registering an athlete for this competition.

2.5.3 **At the competition**, an obligatory medical control will be carried out by a qualified doctor, designated by the organiser. This doctor will decide on the aptitude and state of health of an athlete registered for the competition. The decision to allow the athlete to compete, or not to compete, for medical reasons is his decision alone. It is sovereign and not open to discussion. The decision will be communicated to the Délégué Officiel.

**2.5.4 Anti-doping Control** : For international federations recognised by WADA, anti-doping controls must take place. Anti-doping control applies to all athletes taking part in FISav competitions de la FISav. Anti-doping control can take place at competitions and also outside of competition times.

## 2.6 : Running of the competition

### 2.6.1 Rules of the competition:

- The rules of combat are those given in the regulations of the Fédération Internationale de Savate for competitions in assaut.
- The FISav Délégué Officiel has the right to organise the competition in the form of pools or direct elimination. According to the number of athletes present, he will decide on pools or direct elimination.

### 2.6.2 Results :

In the system of elimination by pools, the following table applies :

Victory :	3 points
Defeat :	1 point
Draw :	2 points
Forfait	0 point
Disqualification :	- 1 point

During the pools, in the case of a draw given by the judges after a combat, the DO could accept the draw or, if he considers appropriate, he could decide on a winner.

In the case of a draw at the end of the pools, the winner is decided according to the following order:

- 1) The winner of the bout between the two athletes.
- 2) The athlete having fewer warnings during the bouts.
- 3) The one who had most victories.
- 4) The one who was lighter at the time of the weigh-in.
- 5) Drawing of lots.

In all cases, the athletes must present themselves to the Délégué officiel of the ring before the combat (even if the athlete wishes to declare forfait for the bout in question). If an athlete does not present himself for the bout, he is considered as having abandoned the competition by the délégué officiel of the Fédération Internationale de Savate.

**No title can be awarded to an athlete if (s)he has not taken part in at least one proper bout with another competitor during the championship.**

## **2.7 : Palettes** (CDI du 11 June 2007, resolution n°10) :

The Délégué Officiel Général can take the decision whether or not judgment will be by palettes at this championship. Training can be given to the officials (judges, referees) present for the competition before the opening of the championship.

## **2.8 : Appeals against decisions.**

(CDI de la FISav. du 14-12-2003, 16<sup>ème</sup> resolution)

Where a decision is contested, only the **Head of Delegation** has the right to deposit an appeal, which must be written on the correct **appeal form**.

In all cases, the principle must respect the following rules :

- The appeal must be deposited with the délégué officiel **no later than 30 minutes** after the announcement of the contested decision.
- To be received, and thus taken into consideration, this appeal must relate only to breaches of the regulations of the competition, and cannot be a contestation of the officials' judgements of the athletes' performances.

An appeal committee composed of the délégué officiel général and the ring delegates will meet to consider the appeal, at a time conducive to the good running of the competition. It will make its decision taking into account the alleged breaches of rules, which may or may not have occurred, and which could result in a reversal of the result. Its decision is without appeal. In case of divide opinion, the délégué officiel général of FISav has the deciding vote.

## 2.9 : Decisions

The winner of the final for each category of weight and gender will be declared Gold Medallist and World Youth Champion 2017 in the specified category of weight and gender. The loser of the final for each category of weight and gender will be declared Silver Medallist and World Youth Vice-Champion 2017 in the category of weight and gender. The losers of the semi-finals will be given the title of Bronze Medallist of the World Youth Championship 2017 in the specified category of weight and gender.

## 2.10 : Unforeseen Situations

Where there is disagreement related to a situation not covered by these regulations, a committee of interpretation will be set up. Its decision is without appeal. This committee must include members of at least 3 nationalities. It is composed of the délégué officiel général, the ring délégués officiels and two persons designated by the délégué officiel général, from the members of the delegations present. In the event of a split decision, the Délégué Officiel général has the deciding voice.

# 3 : Financial Conditions

## 3.1 : Financial responsibilities of the organiser

Article 8.1 of the Convention : The organiser is responsible for the transport costs and food of the délégué officiel général designated by FISav (one person only).  
(CDI of FIS of 11.06.07, resolution n°8)

The CDI of 11th June 2007, confirmed the possibility that the organiser can ask for a financial contribution from the athletes and members of the coaching team.  
**For this competition the financial contribution is 200€ per person (food and accommodation),** all athletes and members of the coaching team are required to pay this. The judges / referees and official delegates accepted by FISav are not affected by this financial contribution.  
The delegations must pay this contribution to the organiser:  
50% at the time of the quantitative inscription (Sunday 7<sup>th</sup> May) (by bank transfer)  
50% at the time of arrival (Note : there is a possibility to pay in advance by bank transfer).  
**To validate the entries, this participation must be paid before the competition to the organiser Mr Siniša KOVACIC.**

Unless otherwise agreed in writing by FISav, the organiser is responsible for providing the environment and all sporting equipment necessary for an international competition in Savate, for example : the gym, the rings, weighing scales, gong, chronos, etc., and all must conform to the FISav regulations. The organiser is also responsible for providing a medical control and medical support.

The organiser will ensure transport is available for the national delegations, from the airport or train station nearest to the place of competition, and between the accommodation and the place of competition, and also for return journeys.

Each nation must provide officials (judges and referees) according to the number of athletes registered for World Youth Championships.

**A national delegation consists of the athletes, the coaches and the judges and referees.**

**Composition of a national delegation:**

- One athlete per category of weight, age and gender;
- One or more (see article 3.1.2)
- One or more officials, judges and/or referees (see article 3.1.3)

**Reminder :** The Head of Delegation is designated from the coaches or the judges and referees (officials).

**3.1.1 : The athletes :**

The organiser Mr Siniša KOVACIC will take responsibility for only one athlete for each category of weight, age and gender.

For each athlete, he will provide:

- **Thursday evening : evening meal and accommodation**
- **Friday: breakfast, lunch, evening meal and accommodation**
- **Saturday : breakfast, lunch, evening meal and accommodation**
- **Sunday : breakfast.**

**3.1.2 : The principle coaches (including the Head of Delegation) :**

For each nation, the organiser will take responsibility for principle coaches according to the following table :

- |                           |           |

**Reminder :** Quota of coaches depends on the total number of athletes.

For the coaches, the organiser will provide :

- **Thursday evening : evening meal and accommodation**
- **Friday: breakfast, lunch, evening meal and accommodation**
- **Saturday : breakfast, lunch, evening meal and accommodation**
- **Sunday : breakfast.**

### 3.1.3 : Judges and Referees (« Officials ») including the Head of Delegation :

Each national delegation is obliged to propose a number of officials (judges or referees) according to the following table :

- from 1 to 2 athlete(s) : 1 official
- from 3 to 5 athletes : 2 officials
- from 6 to 8 athletes : 3 officials
- more than 9 athletes : 4 officials

**Reminder** : Quota of officials depends on the total number of athletes.

**Where a nation finds it impossible to provide the number of officials necessary** as shown above, it **MUST** inform FISav at the time of inscription of the delegation.

A nation may request that another nation provides the necessary officials (judges or referees, decision of FISav CDI 14th December 2003).

**Where a solution is not possible, FISav reserves the right to reduce the number of athletes entered in relation to the number of officials present.**

**For the officials (judges, referees) presented by the nations and accepted by FISav, the organiser will provide:**

- **Thursday evening : evening meal and accommodation**
- **Friday: breakfast, lunch, evening meal and accommodation**
- **Saturday : breakfast, lunch, evening meal and accommodation**
- **Sunday : breakfast.**

**Reminder** : judges and referees accepted by FISav do not pay a financial contribution.

**3.1.4 : Délégué Officiel Général** : with the agreement of FISav, the organiser takes financial responsibility for the food and accommodation of the DOG for the time necessary to organise the competition.

**3.1.5: The FISav rights of organisation :** For this competition (World Youth Championship 2017), the Fédération Internationale de Savate does not ask for rights of organisation.

**3.1.6 : FISav President:** the organiser takes financial responsibility for the food and accommodation of the FISav President.

**3.1.7 : Anti-doing Controls :** The organiser pays the costs of the anti-doing controls if there are any.

**3.1.8 : Medical Costs :** The organiser pays the costs of the medical service (doctor, ambulance)

**3.1.9 : Excluded expenses** (see article 3.2.3)

The organiser is not responsible for any costs incurred by the participants (athletes, officials, coaches or supporters) outside of those covered by these regulations.

## **3.2 : Financial responsibilities of the participating nations :**

**3.2.1 The registration fees** payable to FISav : **20 euros** per athlete and per out-of-quota coach

**3.2.2** The CDI of 11th June 2007, confirmed that possibility for the organiser to request a financial contribution from athletes and members of the coaching team. This contribution covers the totality of the competition (for the 3 days) and relates to **article 3.1 above (Financial responsibilities of the organiser)** It helps the organiser to cover part of the costs, but not to profit.

For the World Championship 2017, the contribution requested from the athletes and coaches team is **200 €** for each athlete and coach, but not for the officials accepted by FISav (to cover the duration of the competition from the weigh-in to the departure after the finals).

For all other persons, not part of the official delegation (accompanying persons, supporters, families, etc), the participation is **230 €** per person to cover the duration of the competition (from the weigh-in to the departure after the finals).

If participants wish to arrive before Thursday 13<sup>th</sup> July or depart later than Sunday 16<sup>th</sup> July, they must first contact the organiser Mr Siniša KOVACIC.

**The Head of Delegation must give the total amount, covering all the relevant members of his delegation, on arrival.** Note : the nations have the possibility to pay this amount in advance by bank transfer, before their arrival (contact the organiser).

### 3.2.3 The travel costs of the athletes, officials and principle coaches :

The participating countries are responsible for the costs of travel (return tickets) for their athletes, principle coaches, and officials designated by their national organisation (according to the limits given in the quotas).

The International Federation and the Croatian Federation must be informed of additional persons, for example, if the delegation wishes to bring more coaches. After agreement from FISav and the organiser, this delegation must pay the total costs of accommodation and food of these additional coaches, or any other additional people accompanying the delegation.

The Croatian Federation must be consulted in advance in order to verify whether it is possible to provide accommodation and food for these additional persons.

### 3.2.4 : Head of Delegation

A Head of Delegation is designated by the national organisation, affiliated to the Fédération Internationale de Savate, **from among the principle coaches or the officials (judges or referees).**

**Attention :** If the Head of Delegation *is neither a coach nor a judge or referee*, (s)he is not considered part of the official delegation and the organiser will not bear any financial responsibility for accommodation or food (not covered by the financial contribution paid).

There can only be one Head of Delegation for each participating nation. (S)he is the spokesperson between the delegation and FISav (Délégué Officiel) and/or the organiser.

The Head of Delegation must contact the organiser, in writing (email, letter), no less than 2 weeks before the start of the competition to inform him of the arrival place, time and date of the delegation. After this date, the organiser is not obliged to take responsibility for the welcome of the delegation concerned.

### 3.2.5 Additional expenses of participants:

**All additional expenses not covered by the organiser** (see article 3.1) **must be paid immediately (in euros or the local currency)** by the person in question, or his/her Head of Delegation (for example, bar charges, hotel supplements, restaurant charges, etc).

Equally, if delegations (or their members) arrive earlier or leave later than the dates given, they must pay all additional costs, and the organiser must have been forewarned and given his approval.

### 3.2.6 Costs associated with damage:

Any damage caused by a member of a delegation (athletes, coaches, supporters, etc.) requiring repair costs must be paid by the federation responsible for the good conduct of its members, including its supporters. It will then be up to the national federation to claim reimbursement from its member (or its supporter) who has caused the damage. In case of difficulty in collecting the sums owed, FISav reserves the right to consider the debt as its own.

Behaviour detrimental to the image of Savate and / or deliberate degradation by members of a federation may lead the FISav to decide on a disciplinary commission against the representative of the federation concerned.

### 3.2.7 Recommendation :

To avoid any errors on the part of the organiser, it is recommended that each delegation brings :

- national flag (maximum size : 1 m x 1.50m) and
- official national anthem, in a useable format.

### 3.2.8 Unjustifiable forfeits:

Any unjustified forfeit, made without warning, by athletes from participating countries may result in reimbursement of costs paid by the delegate organizer to host these athletes.

## 3.3 : Responsibilities of FISav

**3.3.1 :** FISav will receive and register the inscriptions of each affiliated national organisation, and verify the composition of the delegation. FISav will communicate with the organiser and the Délégué Officiel général of the Fédération Internationale de Savate. The DOG, with assistance from the ring délégués officials, organises the bouts of the tournament, with respect to the various regulations of the Fédération Internationale de Savate.

Before the start of the competition, the organiser and the DOG verify that their lists of athletes registered and accommodated agree.

### 3.3.2 : Diplomas and attestations

Each participant (athlete, coach, official) of the championship could ask, at the time, to receive an attestation from Fédération Internationale de Savate for participation in the competition.

The championship winners, finalists and semi-finalists, for each category will receive a diploma from FISav.

No title or diploma can be given to an athlete who has not participated in a bout during the championship.

### 3.3.3 : Images of the competition

Outside of a specific written agreement with the organiser, and in accordance with FISav regulations of the FISav, it has all rights for the photos taken of the competition, including of the participating athletes.
